

## **Terms of Service for Sacred Grounds Affinity Program:**

### **1. Introduction**

Welcome to the Sacred Grounds Connect, our company's program designed to support Christian higher education, Christian healthcare organizations, and other 501(c)(3) nonprofit organizations. By participating in the Program, you agree to be bound by these Terms of Service ("Terms"). If you do not agree to these Terms, you may not participate in the Program.

### **2. Eligibility**

**Students:** To be eligible for the Program, you must be at least 18 years old and enrolled in a Christian college/university. Provide your student ID number of copy of your student ID when enrolling in the program.

**Student Sponsors:** Parents, siblings, grandparents, etc., are eligible to participate in the Program and earn credits for one or more Students listed on their account. A Sponsor must be at least 18 years of age and submit to us in writing the name(s) of their Student participant(s) and the qualified school(s) they attend.

**Organizations:** To be eligible for the Program, an organization provide a completed application documenting its Christian identity and mission, and submit a copy of its IRS tax exempt determination letter. Participation in the Program is subject to our approval, and we reserve the right to modify or terminate the Program at any time without notice.

**Sponsors of a Nonprofit Organization:** To be eligible for the Program you must be at least 18 years old and name an approved 501(c)(3) organization to receive earned credits for that organization.

### **3. Earning Credits**

Participants in the Program earn credits based on their Sacred Grounds Coffee purchases. The number of Credits earned will be determined by us and may vary based on the product or service purchased. Credits may not be earned on non-coffee products, taxes, shipping, and handling, or any other fees.

### **4. Redemption of Credits**

**Students:** Credits earned may only be applied to the cost of tuition, room and board, and student fees at a participating Christian college or university in which the participant is enrolled.

**Sponsors:** Credits earned may be designated for a participating student(s) listed on their account or a Christian nonprofit selected by the participant from the list of participating 501(c)(3) nonprofit organizations approved by Sacred Grounds Coffee, LLC.

**Nonprofit Organizations:** Credits earned shall be distributed to the participating organization selected by a sponsor or if no organization has been selected, credits will be assigned to a participating organization by Sacred Grounds Coffee.

### **5. Value of Credits**

The value and the number of Credits available for redemption are determined by us (80% of the net profit from purchases to the student's school account or a sponsor's participating nonprofit; 20% of net profit is distributed to our company Foundation, Sacred Grounds Ministries, for distribution to nonprofit ministries). The number of credits is subject to change without notice.

Student credits are remitted solely as a reduction of the student's tuition bill, cost of room and board, and other student fees. Colleges reserve the right to use the credits as part of, or separate from, any financial aid packages. Credits have no cash value and cannot be sold or exchanged for cash.

### **6. Unused/Unexpired Credits**

Student participants who graduate or terminate their enrollment at a school shall direct the school to apply any remaining unused credits to the school's general scholarship fund or the school's foundation/endowment. Any undesignated, unused credits by other program participants will be distributed to a 501(c)(3) nonprofit organization chosen by us.

### **7. Distribution of Credits**

Credits shall be distributed upon written request of the Participating Student, Individual, Sponsor, or Organization.

## **8. Expiration of Credits**

Credits will expire after a period of 48 months. We reserve the right to expire or cancel Credits at any time without notice.

## **9. Modification and Termination of the Program**

We reserve the right to modify or terminate the Program at any time without notice. In the event of termination, any unused Credits will be applied to one or more of the 501(c)(3) nonprofit organizations selected by Sacred Grounds Coffee, LLC.

## **10. Limitation of Liability**

We will not be liable for any damages or losses arising out of your participation in the Program, including but not limited to, any direct, indirect, incidental, consequential, or punitive damages. Our liability to you for any reason related to the Program will not exceed the total value of Credits earned by you.

## **11. Privacy**

Participant's personal information will be collected, used, and disclosed in accordance with our Privacy Policy. By participating in the Program, you consent to our collection, use, and disclosure of your personal information solely for the purposes of administering the Program.

## **12. Governing Law**
